Postup certifikace

Exam progress:

- Candidate to complete an on-line application and submit all documents electronically.
- CSQ to evaluate candidate's application.
- Candidate to fill in missing information, if applicable.
- Decision to admit candidate to exam.
- Written exam:
 - 45 questions based on case studies
 - English only
 - time available 120 minutes for native speakers, +15 minutes per every hour for everybody else.

ISTQB exam organisation:

Open exams are held in CSQ premises:

- exam terms apply to CTFL, CTAL and Agile Tester.
- exams are held in CSQ premises, Novotného lávka No. 5, Prague 1, starting at 09:00 am.
- all candidates shall receive an invitation 14 days prior to exam.
- candidates are allowed to use their own hard-copy dictionary (not an electronic one).
- upon finishing the exam, candidates are informed about the number of points they achieved + pass/failed status. They are not allowed to go through the exam files.
- successful candidates are listed in the database of certificate holders available at www.csq.cz within 1 week after the exam. Together with their name, a certificate number is included. Within 3 weeks after the exam, candidates shall receive their certificates electronically via e-mail.
- upon passing the exam, candidates can ask for a printed copy of their certificate.
- failing the exam, candidates can take a resit as per scheduled terms. In such case, it is not necessary to complete the application all over again; it suffices to e-mail your selected date to the contact person.

In-house exams:

- exam dates and times are scheduled upon agreement between CSQ and the client organisation.
- exam terms apply to CTFL, CTAL and Agile Tester.
- exams are held in client company's meeting rooms.
- minimum number of candidates:
 - 5 persons for exams in Prague
 - 10 persons for exams in Brno, Pilsen, Hradec Králové etc.
 - 15 persons for exams in Ostrava
- Prices for in-house exams are the same as for open exams. If less candidates apply, a one-time fee of 1.500 CZK + 21% VAT (travel expenses) can be charged upon prior agreement.
